RULES & REGULATIONS

These Regulations are issued by the Executive Committee of the KCJ under the powers provided by Rule 12(d) in the Constitution of the KCJ and replaces all previous versions.

The Executive Committee shall be empowered to make such other rules or amend rules in accordance with the power granted by the Constitution, as it may consider necessary from time to time in connection with shows held under the regulations of the KCJ. Under Constitution Rule 12(f) "No such change shall be implemented until three weeks after notification" to the Membership of the KCJ.

For the purpose of these Regulations: -

Words importing the masculine gender shall include feminine and neuter genders and vice - versa. Words (which for the avoidance of doubt includes definitions used herein) in the singular shall include words in the plural and vice-versa.

Members of the KCJ. "Members":

The Constitution of the KCJ, Regulations and Codes, as may be amended from time to time. Shall be interpreted to include both sexes, as appropriate. "Rules":

"Dog(s)":

"Exhibitor": Any owner, handler or other person who has responsibility for dogs at a show.

"Show Manager" A member of the KCJ, who is not handling a dog, nominated by the Executive Committee to

oversee a show.

"Show(s)": Any event organised for competition by the KCJ or licensed by the KCJ.

Championship Show: KCJ organised open to all Jersey or Guernsey registered dogs over six months where Jersey

Challenge Certificates are offered.

KCJ organised open to all Jersey or Guernsey registered dogs over six months. Open Show

Members Show KCJ organised open to Jersey or Guernsey registered dogs of which all the exhibits owners are

bona fine members of the KCJ, excluding Champions.

Organised by or held under licence of the KCJ where classes may be set for any pedigree and/or Companion Show:

non-pediaree doas

Matches: Organised by or held under licence of the KCJ open to all Jersey and Guernsey registered

pedigree dogs over 4 months. Shall mean a calendar month. "A month"

"Challenge Certificate (CC)" Shall include any award that counts toward the title of Show Champion in any jurisdictions.

"Champion": Dogs confirmed as Champions by the relevant recognised Canine authority

"Award": A recognised achievement from a recognised Canine authority. Clubs and Societies granted Registered Status by the KCJ. "Registered Status":

"Listed Status" Clubs and societies granted Listed Status by the KCJ.

Are only to be counted if awarded up to 14 days prior to close of entry. A Win shall mean any "Wins"

1st place awarded to an adult exhibit in Jersey or elsewhere, including Any Variety classes. The number, or validity, of such wins shall be as listed in the class definitions printed in the schedule.

"Withdrawal": Any exhibit that is removed from competition by its ring number being returned to a member of

the Executive Committee shall be ineligible to compete in any further competition at that show,

excluding handling. All previous wins remain in effect.

Any exhibit that is removed from competition due to a breach of the Constitution, Regulations "Disqualified":

or Codes of the KCJ shall be ineligible to compete in any further competition at that show and all wins or awards shall be forfeited. Where possible the next placed exhibit will be granted the

awards it would have received had the disqualified exhibit not been present

"Registration Applied For": Any exhibit that, at close of entry, for which an application has been made, with enclosed fee.

to the Registrar for the registration of a new dog, but that all the supporting paperwork has not yet been made available from other jurisdictions. All papers must be with the registrar at least 48 hours before the show. The exhibit must be in the bona-fide ownership of the exhibitor at close of

Any exhibit that, at close of entry, for which an application has been made, with enclosed fee, "Transfer Applied For": to the Registrar for the transfer of a dog into the exhibitor's ownership where the supporting

paperwork has not yet been made available from the previous jurisdictions. All papers must be with the registrar at least 48 hours before the show. The exhibit must be in the bona fide

ownership of the exhibitor at close of entry.

Any registered dog, over 4 months entered "Not for Competition" is ineligible to compete, such a

dog may, however, be used in handling classes, demonstrations or displays.

1. WELFARE OF DOGS AND CODE OF GOOD CONDUCT AT KCJ SHOWS.

- a) An exhibitor should take all reasonable steps to ensure the needs of their dog(s).
- b) If in the opinion of the KCJ, a dog is of savage disposition it shall be ineligible for entry for any show.
- No activity should be conducted which permits, encourages or develops aggression in a dog.
- d) Except when caged all dogs must be on a lead for the duration of a show including the exercising area, except when competing in the ring in an obedience class or agility test or taking part in a demonstration.
- Exhibitors must not pick up dogs by their tails and lead when lifting them, this is not acceptable. This will be classed as harsh handling and the exhibitor and exhibit will be disqualified.
- It is not acceptable to handle a dog(s) in such a manner which causes its feet not to touch the ground when on the move. Exhibitors should note that such practice could constitute harsh handling and could lead to disgualification
- g) The owner, exhibitor or handler or any other person in charge of dogs must at all times ensure the dogs are kept under proper control at the venue, including the showground. This regulation applies at the setup, during the event and the breakdown of the show
- h) All exhibits should have access to water.

"Not For Competition":

- The welfare of all exhibits is the concern of the exhibitor, dogs should not be left in distress, or in conditions where distress may occur.
- The Honorary Veterinary Surgeon or deputy shall be available on call should it become necessary in an emergency.
- All exhibitors are expected to act in a "Spirit of Good Sportsmanship" at all times.
- Abusive behaviour will not be tolerated at any time, neither will discreditable conduct at a KCJ event. After consideration, the Executive Committee reserves the right to refuse entries from any exhibitor found to be guilty of such abusive behaviour or discreditable conduct for a maximum of six shows organised by the KCJ.
- m) While every precaution shall be taken to ensure the safety of all persons, exhibits or property within a show precinct the KCJ shall not accept any responsibility for any injury, damage or loss caused to, or by, any such persons or exhibits.

n) Parents or guardians (whether present or not) will be held responsible for any minor (under 16 years of age) under their control. Should a complaint be received against any minor, the parent or guardian will be held responsible as if they themselves were the cause of such a complaint and shall be liable for damage and loss however caused.

2. SHOW ENTRY AND ELIGIBILITY

- a) Show licenses will only be issued to Affiliated clubs only.
- b) Dogs entered for exhibition at KCJ licensed shows, except for Companion Dog Shows, must be registered with the KCJ in accordance with the KCJ Registration Regulations or Guernsey Kennel Club (GKC).
- c) Persons disqualified or suspended under the KCJ Rules are not permitted to take part in any KCJ licensed shows.
- d) The age of all dogs and puppies shall be taken on the first day of a show, except from those competing in the Dog of the Year finals.
- e) Only dogs of six calendar months of age and over on the first day of a show are eligible for exhibition at KCJ run or licensed shows. At the discretion of the Show Secretary dogs aged four calendar months and over are eligible to enter Not for Competition at the aforementioned. Furthermore, dogs aged four calendar months and over are eligible to enter matches.
- f) Permission should be sort from the KCJ Executive Committee for any operation to an exhibit which gives it an unfair advantage if shown. An exemption may be granted based on individual circumstances at the discretion of the Executive Committee if it is felt that the operation was performed for the welfare of the dog and not for unfair gain. Subject to an exemption being granted, a dog cannot be entered if:
 - i. totally blind
 - ii. totally deaf
 - iii. it has cropped ears
- iv. the owner/exhibitor is under suspension.
- g) Should any dog be reported by a judge as suffering from any of the foregoing, the dog shall be disqualified immediately and any awards at that show shall be forfeited.
- h) No dog may be exhibited until the Registrar is satisfied that all paperwork is in order and has issued a registration number. No entry fees will be refunded should the paperwork not be in place by the day of the show.
- i) Entry forms for shows held by the KCJ, save for matches and companion shows, shall contain, in full, the registered name of the dog, the date of birth, the names of the sire and dam. It is the owner's responsibility to ensure the accuracy of the information provided. Where a dog is owned by more than one person it may be signed by one of the owners in good faith. Entries received by email will be considered signed by the sender of the email.
- j) The Show Secretary reserves the right to recommend to the Executive Committee that an exhibit be refused entry, provided he can give just cause. The Executive Committee shall have the final right to refuse entry and, if upheld, any payment refunded
- k) In the case of a dog owned in partnership and entered in a class where the owners have to be members of the KCJ each partner must at time of entry be a member of the KCJ.
- Class entry fees for events organised by the KCJ will be decided by the Executive Committee and printed in the show schedule or appropriate documentation.
- m) Definitions of classes shall be printed in the show schedule or appropriate documentation.
- n) Entry will close as set out in the show schedule or appropriate document. Late entries will not be accepted.
- No entry will be accepted unless accompanied by the full amount of the fees and duly completed entry form.
- p) The entry fee for a dog entered and not exhibited will be forfeited.
- q) If any dog, owner, exhibitor, and/or handler is entered for a class for which they are not eligible, entry money shall be forfeited, unless it can be shown that the error is not of the exhibitors making.
- r) The Executive Committee reserves the right to disqualify any dog, owner, exhibitor and/or handler from an award won in a class for which they were not, for any reason, eligible and it will be the owner's or handler's in the case of a handling class, responsibility to cover any associated costs such as, but not limited to, amending engraving or replacing trophies and/or receites.
- s) If an exhibitor reports before the judging of a class or classes that a dog has been entered which is ineligible, the exhibitor may choose one of the following options.
 - i. Withdrawal The dog may be withdrawn from competition.
 - ii. Transfer—if a dog is ineligible for a class or classes as regards its breed, colour, sex, weight or height the show secretary shall transfer it to the equivalent class or classes for the correct breed colour, sex, weight or height, or in the event there being no equivalent class the dog will be transferred to the Open Class for the correct breed.
 - iii. If an exhibit is entered incorrectly in a Minor Puppy class, Puppy class or Junior class which is over age but under 12 calendar months of age, 18 calendar months of age or 24 calendar months of age respectively, the show secretary shall transfer the exhibit to the Puppy class, Junior class or Yearling class as appropriate.
 - iv. For any reason other than the above the Show Secretary shall transfer it to the Open Class for the correct breed, colour, sex. weight or height.
 - v. If an exhibit arrives late or misses a class, even if it is the only class which the dogs is entered, the dog may not be transferred to any other class. Such a dog may however take part in handling classes only.
- t) The Show Manager shall have the right to exclude any dog which is not in a fit state for exhibition due to disease, vice or any other cause; if such exclusion takes place before or after the dog is judged, the entry fee will be forfeited.
- u) All breeds shall be judged against their Kennel Club Limited (UK) Breed Standard, unless clearly marked in the show schedule.
- v) Classes shall be made up for each show allowing for the best competition possible, at the discretion of the Show Secretary.

 At a Members Show
- i. A dog with Champion or Show Champion status in any jurisdiction shall be ineligible for entry, save where special classes are scheduled, and judged after Best in Show.
- w) In Brace or Team classes, it shall only be necessary for an exhibitor to nominate and pay for one of the dogs at time of entry. All exhibits shown in Brace or Team classes must have been entered into at least their Breed or Veteran classes and have completed all previous classes entered.
- x) All Executive Committee Members, unless they have been nominated as Show Manager, may exhibit at a show. However, direct contact, including the use of social media, with judges should be kept to a minimum before and during a show.
- y) No person, handling at a show shall attend or host the pre-show meal with the Judge(s).
- z) Judges shall not stay with a member of the KCJ before a show where the member has an exhibit at that show. Exhibiting or handling shall mean any dog which the member has bred, has owned or has handled in the previous year.

3. REGULATIONS FOR EVENTS RUN BY THE KCJ EXECUTIVE COMMITTEE.

- a) Apart from exhibits entered into a show, or entered "Not for Competition", no animal shall be allowed within the showground without the permission of the Show Manager. Notwithstanding, no dog less than six months may be permitted within the showground; with the exception of a Match or Companion Show, where a class for 4 to 6 months old exhibits has been advertised.
- b) The Executive Committee will be most concerned for the care and safety of dogs and exhibitors during a show but will not be responsible for the loss or damage to any exhibit(s), person or other property whatsoever the cause, nor for any act of omission by themselves and others and it is on this understanding that entries are received.
- c) The judging will commence at the time advertised in the schedule or other relevant documentation. A show will be open to the public on such payment, if any, as may be decided upon by the Executive Committee. Exhibitors will be admitted free of charge.
- d) Should any judge be prevented from fulfilling his engagement, the Executive Committee shall be empowered to make alternative arrangements. Changes shall be notified to exhibitors as soon as practicable by the most appropriate means. If f a judge is changed after entries have closed Regulation 3 (f) shall not apply. However, should an exhibitor wish to withdraw an exhibit because they would normally contravene Regulation 3(f) they may do so, and receive a refund of fees paid.
- e) Judges must judge in accordance with the UK Kennel Club Limited's Breed Standards. In assessing dogs, judges must penalise any features or exaggerations which they consider would be detrimental to the soundness, health or wellbeing of the dog. Judges are also expected to maintain and abide by the KCJ Rules and Regulations and appropriate Codes of Best Practice.
- At any show, a judge shall not judge any exhibit in which he has an interest. A judge shall be deemed to be interested in any exhibit if he, singularly or jointly,
- i. bred the exhibit
- or has within the preceding twelve months: -
- ii. owned the exhibit
- iii. handled the exhibit
- iv. prepared the exhibit
- v. boarded the exhibit.
- The mating of bitches within the confines of show grounds is strictly forbidden.
- h) The Executive Committee may add other attractions to any show if it so deemed beneficial to the KCJ
- The Executive Committee shall decide upon the judges to be appointed. Members may submit, in writing, names of judges they wish to be considered for appointments.
- j) Invitations to judge must be made by the Show Secretary in writing and they must ensure that written acceptances are received. Upon receipt of the written acceptance a judging contract is formed.
- k) The KCJ is required to include the following wording in the judging invitation letter: In accepting this invitation, you agree to be bound by the Kennel Club of Jersey's Rules and Regulations and the U.K Kennel Club Limited's Code of Best Practice for Judges. In doing so you recognise that you are obliged to notify us in writing of any change in personal circumstances which will affect your ability to fulfil this judging appointment. You should also note that we reserve the right to cancel the contract before the date of the appointment if there is any change in your circumstances, which in our reasonable opinion, would adversely affect your ability to fulfil the appointment.
- All judge's contracts are subject to cancellation at the discretion of the KCJ Executive Committee.
- m) No notice of any description shall be posted in the precincts of a show without the consent of the Show Manager. All stud advertisements are strictly forbidden.
- n) In the event of the abandonment of a show for any unforeseen circumstances whatsoever, the KCJ may defray such expenses from the entry fees so as to cover the cost of the show.
- Once an exhibit has arrived at the showground it cannot leave, without the permission of the Show Manager, until all its classes have been completed. Should it qualify for special awards these will be regarded as classes to be completed.
- p) If not at ringside when required for judging, the Executive Committee or its agents will not be responsible for an exhibits absence from the show ring: the onus is on the exhibitor to be present and not unduly delay judging.
- q) No person shall be allowed in the judging ring except those exhibiting in the current class or those engaged in their official duties.
- No dog shall be allowed in the judging ring other than the actual exhibits in the class being judged.

 s) Any Group winners shall be permitted to withdraw from further classes and still be eligible to compete for Best in Show.
- t) The attraction of the exhibits or exhibitors' attention from outside the ring is prohibited, where an unfair advantage may be gained it is not allowed even at the judge's or stewards discretion.
- u) The wearing of any Badge of Office, affix, or any club affiliation, or awards whilst handling an exhibit in the show ring is prohibited. Prominent displaying of affixes, Club affiliations, awards or dog's names in the proximity of the ring is to be discouraged and should be removed on request of the Show Manager.
- v) A judge may withhold any award if he considers that such an award is not merited.
- w) Any fouling in the showground, or adjacent areas, should be cleared up, and disposed of in the bins provided, or removed from the showground by the exhibitor, handler and or owner. Any person failing to comply with the rule may have their exhibits disqualified.
- x) It must be understood that the judges' decisions are final, except in the case of fraud or misrepresentation or where a bona fide mistake has been made by the judge or where an objection is upheld.

4. DISQUALIFICATIONS OBJECTIONS & COMPLAINTS RELATING TO EVENTS ORGANISED BY THE EXECUTIVE COMMITTEE OF THE KCJ.

- a) In the event of an objection being received in writing with the appropriate non-refundable fee paid, equal to the Annual Subscription to the Show Manager by an exhibitor, against any exhibit entered into the show on the ground that:
 - It has had an operation that will give it an unfair advantage and an exemption has not been granted by the Executive Committee, and/or
 - ii. Is suffering from an infectious or contagious disease, and/or
 - iii. Is excluded under Regulation 2(f).
 - The Show Manager or Executive Committee may investigate the objection and if required request the Hon. Veterinary Surgeon, or his representative to be called to examine the dog and give his opinion in writing to the Show Manager before the close of the show. If in the opinion of the Show Manager, and after consultation with the Hon Veterinary Surgeon, or his representative, if called, the objection is justified all award and placing made to the dog objected to shall be held in abeyance until the objection has been considered by the Executive Committee.
- b) Other than provided for in Regulation 4 (a), all matters of dispute at a show organised by the KCJ, or any objection that the Show Regulations have not been adhered to, should be referred to the Show Manager, on the day and the appropriate non-refundable fee paid, equal to the Annual Subscription. The Show Manager shall then investigate the objection, take action if appropriate, and report to the Executive Committee at the next meeting.
- c) In the event that a complaint relates to an exhibit owned by the Show Manager it should be referred to any other officer who is not connected to the complaint.

- d) In addition to any objection made during a show, a complaint may be made in writing, with the appropriate non-refundable fee paid, equal to the Annual Subscription, to the Honorary Secretary within seven days of the relevant show for consideration by the Executive Committee. The Executive Committee shall also be empowered to investigate any observed irregularities with regard to the show and associated paperwork.
- e) All objections and complaints shall be considered by the Executive Committee at the next Committee Meeting. Should the Executive Committee feel further action is justified it shall give notice of the terms of the objection or complaint to the person concerned, who shall be entitled to
 - i. Make a statement in writing to the Hon Secretary within 14 days of the notice being served
 - Appear in person before the Executive Committee, such a date to be arranged in writing through the Hon Secretary
 within 14 days The Executive Committee shall then come to a final decision as to uphold the objection or complaint or
 not
- f) All objections and complaints will be decided upon by the Executive Committee and its decision shall be final, and will be advised to all parties concerned by the Hon Secretary.
- g) Should the complaint or complaints be made against a member of the Committee, that person shall withdraw from the meeting while the complaint is considered.
- Persons disqualified or suspended under the KCJ Rules are not permitted to take part in any KCJ licensed shows. title of Jersey Champion and may place the letters "Jsy CH" in front of the exhibits name.
- i) Crufts qualification may be offered at Championship Shows, such awards shall be indicated in the show schedule.
-) Best In Show, and Best Puppy In Show, selection shall be made from Group 1 winners and placement shall be in reverse order.

5. TROPHIES AND AWARDS FOR KCJ ORGANISED EVENTS

- a) No trophies shall be taken outside of the Channel Islands. The Executive Committee also hold the right to bar trophies, of particular value to the KCJ, from leaving Jersey.
- b) Any person wishing to donate a trophy should write to Executive Committee to ensure that such a trophy is required, and that the class to which it will be allocated will provide fair competition.
- c) Trophies shall only be accepted by the Executive Committee under the condition that if the particular class for which the trophy is awarded shall cease to exist, the trophy may be reallocated at the discretion of the Executive Committee.
- d) The Committee shall appoint a Trophy Steward who need not be a member of the Executive Committee, but must be a member of the KCJ.
- e) Should the Trophy Steward feel that a trophy is not currently active he may request of the Executive Committee that it is to be archived until such time it is again required, or to have it re-allocated to a new purpose.
- f) The Trophy Steward shall provide the Treasurer with a register of all trophies owned by the KCJ and of the current holders of each trophy.
- g) All trophies remain the property of the KCJ, unless won outright, and must be surrendered upon request.
- h) No exhibitor winning a trophy may take the trophy unless he signs a receipt for it, a copy of such to be retained by the Trophy Steward.
- i) Trophies signed for are the responsibility of the signer in case of loss or damage; also trophies may not be handed over to a third party without consent from the Trophy Steward, and the trophy records being updated and counter signed.
- j) All trophies should be returned, clean, to the Trophy Steward.
- k) Any exhibitor failing to return a clean trophy 10 day prior to the date of a show without good reason may have their entries revoked by the Show Manager with all fees being forfeit. Notwithstanding all trophies should be returned to the Trophy Steward in good time for them to be re-presented. Failure to return trophies may result in suspension from future shows. Trophies should also be surrendered upon written request of the Trophy Steward.
- 1) The cost of additional plaques or new bases shall be borne by the KCJ only if the Trophy Steward has been informed of any such addition before being made. The Trophy Steward shall have received confirmation from the Honorary Treasurer that the KCJ is willing to accept such cost before any work is undertaken.
- m) Jersey Challenge Certificates and Reserve Challenge Certificates shall be on offer to Group 1 and Group 2 winners respectively at Championship Shows, subject to the discretion of the judge.
- n) Any exhibit having been awarded three Challenge Certificates, from three separate judges (apart from exclusion in regulation 25), and after ratification by the Executive Committee, shall be awarded the title of Jersey Champion and may place the letters "Jsv CH" in front of the exhibits name.
- o) Crufts qualification may be offered at Championship Shows, such awards shall be indicated in the show schedule.
- p) Best In Show, and Best Puppy In Show, selection shall be made from Group 1 winners and placement shall be in reverse order.

6. HANDLING REGULATIONS FOR KCJ ORGANISED EVENTS

- a) Only dogs of six calendar months of age and over on the day of competition are eligible for entry into a handling class.
- b) Dogs must be entered in a breed class to participate in a handling class.
- c) Entries for handling classes should be signed by the Parent or Guardian if the handler is below the age of 16. A separate entry form should be completed and signed by any handlers over the age of sixteen.
- d) All handlers competing in the handling classes should be members or junior members of either the KCJ or GKC.
- e) Handling classes will be will be held at an appropriate time as designated by the Executive Committee and listed in the schedule.
-) Class Definition
- Classes for handling are decided by the handlers age
- I. 6 11 years (6 years and up to but not including 12th birthday)
- II. 12-16 years (12 years and up to, but not including 17th birthday)
- III. 17-24 years (17 years and up to, but not including 25th birthday)
- IV. 25 + years (25 years plus)
- g) The name and age of the handler together with the class number must be provided on the entry form provided for this purpose.
- h) Entries will not be taken on the day of a show.
- Parents or guardians must be present and will be held responsible for any minor (under 16 years of age) under their control. Should a complaint be received against any minor, the parent or guardian will be held responsible as if they themselves were the cause of such a complaint and shall be liable for damage and loss however caused.
- j) No person shall be allowed in the judging ring except those exhibiting in the handling class or those engaged in their official duties
- k) Any objection or complaints will be held in accordance with the KCJ Rules and Regulations stated above.

7. BREED DOG OF THE YEAR COMPETITION.

a) This is an invitational event; the invites will be sent with the owners and dog's details as they were at the time of qualifying.
 Any changes to ownership or show name and/or eligibility must be made in writing on the return of the invite.

- b) The onus is upon the owner, any changes not confirmed with the KCJ could result in the owner and exhibit being disqualified from the event
- c) Entries must be made on the invitation and cannot be taken on the day.
- d) These regulations should be read in conjunction with all other Regulations contained herein.
- e) The following are qualifying classes:
 - CHANNEL ISLANDS BREED SHOW DOG OF THE YEAR
 - i. Group 1 places from all KCJ Championship, Open and Members Shows.
 - ii. Group 1 places from all GKC Open and Members Shows.
 - CHANNEL ISLANDS BREED SHOW PUPPY OF THE YEAR
 - i. Puppy Group 1 places from all KCJ Championship, Open and Members Shows.
 - ii. Puppy Group 1 places from all GKC Open and Members Shows.
 - CHANNEL ISLANDS BREED SHOW BRACE OF THE YEAR
 - i. All Best Brace in group winners from all KCJ Championship, Open and Members Shows.
 - ii. All Best Brace in group winners from all GKC Open and Members Shows.
 - CHANNEL ISLANDS BREED SHOW VETERAN OF THE YEAR
 - i. All Best Veteran in group winners from all KCJ Championship, Open and Members Shows.
 - ii. All Best Veteran in group winners from all GKC Open and Members Shows.

DEFINITION OF CLASSES

vaauP

For dogs of 6 and not exceeding 12 calendar months of age on the day of the show.

Junio

For dogs of 6 and not exceeding 18 calendar months of age on the day of the show.

Yearling

For dogs aged 12 months but not exceeding 24 months on the day of the show.

Marrian

*For dogs which have not won a Challenge Certificate** or a First Prize at 14 days before close of entries.

Limit

For dogs which have not won 3 Challenge Certificate** or 8 First Prizes* at 14 days before close of entries.

* - Wins as Puppies, or those at MEMBERS or OPEN SHOWS do NOT count.

**Challenge Certificate shall include any show award counting towards the title of Champion in any jurisdiction.

Open Open to all.

Veteran

A Dog of 7 years of age or over on the day of the show (does not need to be entered in breed class).

AVNSC Import

For breeds confined to the Imported Breeds Register and only when an interim Breed Standard has been published by The Kennel Club. Such Breeds may be exhibited in this class only, with the winning dog Best Imported Register / Best Imported Register Puppy being eligible for Best in Group / Best Puppy in Group or Best in Show / Best Puppy in Show as relevant.

ANY VARIETY NOT SEPARATELY CLASSIFIED

For breeds of dog for which no separate breed classes are scheduled.

Any Variety

A Variety Class is one in which more than one breed or variety of a breed with a breed standard can compete.

Brace

For 2 exhibits of the same breed owned by the same exhibitor(s), having completed all previous classes.

Team

For 3 exhibits of the same breed owned by the same exhibitor(s), having completed all previous classes.

Exhibitors Class

Open to any exhibit, owner or handler, never having won an ADULT GROUP or won this class at a previous show.

Special Vintage

Open to any exhibit over the age of 10 years. Does NOT have to be entered previously in show.

Therapy Dogs Nationwide Open Stakes

Open to all even if not a volunteer of TDN. Prizes for 1st to VHC places. Entry fees from this class will all go to the Therapy Dogs Nationwide Charity.

Good Citizens Class

Open to any exhibit and owner who have been entered into their breed class or veteran and have achieved minimum of their bronze award. Proof of achievement will be sought by requesting sight of the GCDS certificate on the day or a copy sent with entries to be placed on file for future reference.

Not for Competition

Any registered dog, that is required to be on the showground on the day. Must be registered with the KCJ or GKC and be over 4 months old.

WELFARE OF DOGS

Anyone whose dog is entered at a Kennel Club licensed event should take all reasonable steps to ensure the needs of their dog(s) are met, and should not put a dog's health and welfare at risk by any action, default, omission or otherwise. Breach of Kennel Club Regulations in this respect may be referred to the Board for disciplinary action under Kennel Club Rules and Regulations.

Right to Refuse Entries: Exhibitors/Competitors are reminded that show societies have the right under Kennel Club Regulation to refuse any entry.

EXHIBITORS PLEASE NOTE
