In case of dispute proof of postage of such applications may be required by The Royal Kennel Club. Puppies under 6 months of age on the first day of the show cannot be entered for competition. On no account will entries be accepted without fees. If a dog is in the process of Registration or Transfer at the time entry is made, add the letters NAF or TAF as appropriate after its name. Please put classes in numerical order and USE BLOCK CAPITALS throughout when completing this entry form. ADDRESS WITHHELD FOR PUBLICATION

Please note the points below:

2. Your address is still needed for the sending out of schedules and exhibitors passes. So you must still enter your address in the normal way.
