The name of the dog and all the details as recorded with The Royal Kennel Club must be given on this entry form. If an error is made the dog may be disqualified by the Committee of The Royal Kennel Club. All dogs must be REGISTERED at The Royal Kennel Club in the name of the exhibitor. If the registration or transfer of ownership has not been confirmed it must be applied for before the closing date of entries. In case of dispute proof of postage of such applications may be required by The Royal Kennel Club. Puppies under 6 months of age on the first day of the show cannot be entered for competition. On no account will entries be accepted without fees. If a dog is in the process of Registration or Transfer at the time entry is made, add the letters NAF or TAF as appropriate after its name. Please put classes in numerical order and USE BLOCK CAPITALS throughout when completing this entry form. I/We declare that where any alteration has been made to the natural conformation of the dog(s) the relevant permission to show has been granted by The Royal Kennel Club. I/We further declare that I believe to the best of my knowledge that the dogs are not liable to disqualification under Royal Kennel Club Show Regulations. Please note the points below:
