## Useful Information for Exhibitors

Judging of Breed classes will commence from 9.00am (please check DCDSS Facebook page and Higham Press web site) each day. YKC Handling and RKC Breeders Competition commence at 8.30am. AVNSC and Imported Register Breed classes will be judged in the Main Ring at 9.00am.

Benching will still be in place which means that there will be -

### **NO FACILITIES FOR GAZEBOs: TENTS OR FISHING UMBRELLAS WITHIN THE SHOWGROUND.**

In the unlikely event that we must go back to Covid restrictions we will of course comply with all of them.

The Officers and Committee are looking forward to being able to welcome you to our show where the usual greetings will be given. The aim will be to keep everyone as safe as possible; we ask that those attending please help by following all directions, instructions and requests being made of them.

Please display your CAR PARK pass in a prominent place in your vehicle windscreen to aid the Steward to easily see it and therefore direct accordingly.

Stewards will be on hand to direct vehicles into the Car Parks, please follow their instructions. Do not park in any areas other than those designated for Exhibitors.

Parking facilities for Disabled Exhibitors and Visitors. There will be a limited number of spaces for the use of disabled exhibitors and visitors. Vehicles displaying the Official Disabled Parking sign will be directed by the Car Parking Staff on the day.

Gangways are specifically a safety device and must not be obstructed at any time, they are not for the use of spectators. Any obstruction including dog cages left in gangways will be removed by the Show Management

Within each ring a grooming table provided for the Judge to examine the Exhibit (if required) together with a ramp (if required).

Exhibitors Passes; You will not receive your on-line Exhibitors Pass through the post because they will be delivered to you through your on-line account. You will be informed by an e-mail when your passes are ready, which will be approximately one week before the show. The e-mail will include details on how to print your Exhibitors Pass and any other Show Information. You must print your Exhibitors Pass and take it to the Show. Exhibitors making postal entries will receive their Exhibitors Passes by post in the usual way. If you have not received your e-mail one week before the start of the show, please contact the printers. Those having entered via postal entries will receive their passes in the usual way,

**There will be competitions for Best Puppy in Group/Show, Best Veteran in Group/Show and Best Special Beginners in Group/Show.** Those eligible to compete for Best Veteran in Group/Show are dogs/bitches entered in Breed, AVNSC and AV Imported Breed Register Veteran classes only, likewise the same applies to Best Puppy

## **Driffield Championship Dog Show Society**

Since the inception of the original Driffield and East Riding Agricultural Society in 1853, the Society has maintained a strong and enduring association with the agricultural community.

In 1875, the Yorkshire Show was held in Driffield, where the Rev. Jack Russell — a newly elected member of the then two-year-old Kennel Club — travelled from Barnstaple to judge one of the eleven packs entered in the Hound Show. Classes for dogs were introduced in 1899; however, by 1905 they were discontinued due to financial losses. It was not until 1955 that dogs were once again scheduled, attracting entries of 131 dogs.

From 1959 onwards, the dog section gained momentum. Under the guidance of Peter Kaye, a separate dog section was established, with Peter running the Open Show. Over the years, the section expanded significantly, culminating in more than 2,000 dogs entered across 225 classes for the Agricultural Society's Centenary Show.

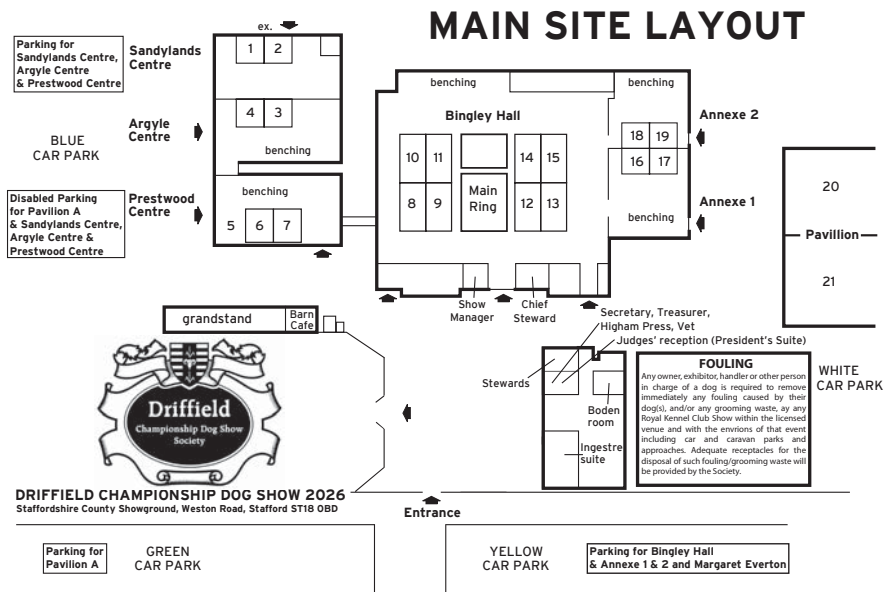
An application was subsequently made to The Kennel Club for Championship Show status. Following due consideration and formal discussions, Driffield was awarded 35 sets of Challenge Certificates for its first General Championship Show, held over three days — 19th, 20th and 21st November 1976 — at Doncaster Racecourse.

Over the following 29 years, the show continued to grow, welcoming many new breeds and expanding to four days with the addition of the Pastoral Group. Marquees were also introduced to accommodate outdoor areas at the Racecourse. However, redevelopment of the Doncaster Racecourse, including the construction of a modern hotel within the grounds, necessitated the search for a new venue. In 2005, the show relocated to Wetherby Racecourse, which met most of the Society's requirements.

While the outdoor venue proved excellent in favourable conditions, it also brought significant challenges when weather conditions were poor. Over the next 19 years, persistent issues arose due to rain and wind, with several incidents causing structural damage to modern aluminium-framed tents. The culmination of these challenges occurred in 2024, when Storm Lillian struck within an hour of the show's scheduled opening. The Best in Show and benching tents were rendered unusable, forcing the abandonment of the show.

After much deliberation, the Committee applied to relocate to Stafford Showground. With the support of the Royal Kennel Club, the Society is delighted to confirm that its Golden Anniversary — the 50th Championship Show — will be held at its new home. Throughout its history as a General Championship Show, Driffield has remained proud of its Yorkshire roots. Known affectionately as "The Friendly Show", this reputation has been earned through the continued support of exhibitors, judges, traders and committee members alike. This spirit and commitment will continue as the Society embarks on this exciting new chapter.

# EVENT PLAN



## EMERGENCY PLAN

- In the event of an emergency you will be warned by 3 short blasts on an air horn, repeated 4 times at 15 second intervals. This will be followed by a tannoy announcement where possible.
- Proceed at once to the muster areas, these are located either side of the entrance road. Do not stop to collect belongings other than what you absolutely need (phone, purse/wallet etc.) Be aware of your surroundings and look out for any hazard as you proceed.
- Marshalls will be on hand to assist and direct all attendees to the correct areas. Do as instructed and under no circumstances attempt to leave the showground or return to vehicles until instructed safe to do so by the marshalls or emergency services.
- The emergency command post is the Chief Steward's office.
- Emergency services will be met at the entrance by a marshall and directed where required.
- In the event of a fire, raise the alarm and move quickly away from the area, do not attempt to fight the fire.
- In the event of a medical emergency proceed to the Medical area, located in the foyer.
- If you notice a suspicious package or person(s) do not approach. Alert a marshall to your concerns and move away from the area and await further instruction.
- The all-clear will be notified by one long continuous blast of an air horn .

**FREE CAR PARKING**

Car Parking is Free. Parking facilities for Disabled Exhibitors and Visitors. There will be a limited number of spaces for the use of disabled exhibitors and visitors. Vehicles displaying the Official Parking sign will be directed by the Car Parking Staff on the day.

**CARAVANS / MOTORHOMES**

Caravans arrivals Thursday 27th August until Tuesday 1st September £60 (If sent with entry fee) or £65 (If paid on arrival). Caravans will be allowed on site from on Monday 24th August (**not before 2.00pm**) and stay until 12.00 noon on Tuesday 1st September £80 (Pre-Paid) or £85 (on arrival). Caravans one night only £20 (Pre-Paid or on arrival) Caravans will be allowed on site from 2.00pm on Monday 24th August and stay until 12.00 noon on Tuesday 1st September

Facilities include a toilet block (including disabled), shower block (in main building and accessible 24 hours), chemical disposal point and a fire point. A woodland site is available for exercising dogs on the strict understanding that dogs are kept on a lead at all times and any fouling is removed immediately, as this is a picnic area.

**DOGS ENTERED NOT FOR COMPETITION**

Dogs may be entered not for competition (entry fee £10.00). The entry must be made on the entry form and details of the dog given. They must be three months or over on the first day of the show. Spectator dogs will be allowed, entry on the day.

**ACCOMMODATION**

A wide selection of accommodation is available within easy reach of the Showground. Stafford town centre is just 3 miles away offering a range from simple B&B to four star hotels. For a detailed list please contact Stafford Tourist Information Centre (TEL: 01785 619619). It is recommended that exhibitors ensure that their chosen establishment will accommodate dogs prior to booking.

**FOULING**

Any owner, exhibit, handler or other person in charge of a dog is required to remove immediately any fouling caused by their dog(s) and any other grooming waste, at any Royal Kennel Club Show within the licensed venue and within the environs of that event including car and caravan parks and approaches. Adequate receptacles for the disposal of such fouling/grooming waste will be provided by the Society. It is not acceptable to "pick up" after your dog and then leave the bag underneath your vehicle or other vehicle, for others to collect at the end of the day.

**BOXES AND CAGES**

There will be areas for boxes and cages. Gangways must be kept clear and any obstructions or dog boxes left in gangways will be removed by authorised officials.

**CAGES WILL NOT BE PROVIDED FOR TOY DOGS**

# Drifffield Championship Dog Show

## Rules and Regulations

- 1 The Show will open at 7.15 am on each day.
- 2 Dogs will be received until 11.00 am and after which no dogs may be received except under exceptional and unforeseen circumstances and by special permission of the Show Management.
- 3 Judging will commence at 9.00am (please check DCDSS FB page and Higham Press web site) each day.
- 4 Exhibits may be removed from the Show after their judging has been completed. Exhibits may not be removed any earlier unless by written order of the Veterinary Surgeon, Veterinary Practitioner or of the Show Management and then only in very exceptional and unforeseen circumstances which must be reported to The Royal Kennel Club. The Show will close half an hour after all judging has been completed by which time dogs must be removed.
- 5 Entry Fees (all include VAT): Breeds with CC's: £32.00 1st entry per dog; Breeds without CC's: £16.00 1st entry per dog; Each subsequent entry with same dog: £5.00; Not for Competition: £10.00; Stakes & YKC: £16.00 if 1st entry, £5.00 if subsequent entry. 5 dogs or more with the same ownership: £130.00. RKC Breeders Competition: £15.00 Catalogues: Full Day Catalogues £8.00 prepaid (to be collected by 11.00am) Single Group £7.00 prepaid (please indicate which Group required) to be collected by 11.00am; Caravan: £60.00 if pre-booked: £65.00 if paid on arrival. Caravans One night only £20 (Pre-Paid or on arrival). Caravans will be allowed on site not before 2.00pm on Monday 24th August and stay until 12.00 noon on Tuesday 1st September £80.00 (Pre-Paid) or £85.00 (on arrival). PLEASE NOTE: There will be an additional charge of £2.00 for each first entry made on-line after Friday 17th July 2026. You may enter online at [www.highampress.co.uk](http://www.highampress.co.uk). ENTRY FEES, ONCE RECEIVED, WILL ONLY BE REFUNDED ON PRODUCTION OF A VETERINARY CERTIFICATE OR A MEDICAL CERTIFICATE **PRIOR TO THE SHOW**
- 6 There will be no Prize Money in the Breed or A.V.N.S.C. classes with the exception of Sponsored Toy Breeds. See adverts for Stakes classes.
- 7 The committee reserves to itself the right to refuse entries.
- 8 Puppies under six calendar months of age on the first day of the Show are not eligible for exhibition.
- 9 The mating of bitches within the precincts of the Show is forbidden.
- 10 Best Puppy in Show (if scheduled)
 

Where a Best Puppy in Show competition is scheduled the Best Puppy in Show is a puppy which has competed and has been declared Best Puppy in Breed, Best Any Variety Not Separately Classified Puppy or Best Any Variety Imported Breed Register Puppy. A puppy is a dog of six and not exceeding twelve calendar months of age on the first day of the Show. The selection of Best in Show may follow the selection of Best Puppy in Show and Best Veteran in Show (if scheduled) respectively. Where the Best of Breed, Best in Group or Best in Show is a puppy it may, at the discretion of the judge, be awarded Best Puppy in Breed, Best in Group and Best Puppy in Show respectively. Similarly, if the Reserve Best of Breed, Reserve Best of Group or Reserve Best in Show is a puppy which has only been beaten by an adult dog it may, at the discretion of the judge, be Best Puppy in Breed, Best Puppy in Group and Best Puppy in Show respectively.

A. Shows Judged on the Group System - (Definition; Shows judged on Group System - Refer to Regulation F(1)27.b)

  - 1) Best Puppy in Breed
 

A Best Puppy may be declared in each breed from puppies entered and unbeaten by another puppy in the breed classes.  
A Best Puppy may be declared from the Any Variety Not Separately classified class(es).  
A Best Puppy may be declared from the Any Variety Imported Breed Register class(es).
  - 2) Best Puppy in Group
 

Best puppy in group and subsequent puppy group placings must be selected from:-

    - a) Those puppies declared Best Puppy in Breed
    - b) The puppy declared Best Puppy from the Any Variety Not Separately Classified classes in each group
    - c) The puppy declared Best Puppy from the Any Variety Imported Breed Register classes in each group
  - 3) Best Puppy in Show
 

Best Puppy in Show must be selected from the Best Puppy in group winners.
- 11 **Best in Show**

The dog declared Best in Show is a dog which has competed and has been declared Best of Breed, Best Any Variety Not Separately Classified or Best Any Variety Imported Breed Register.

(a) **Shows Judged on the Group System**

  - (1) **Best of Breed**

Where a breed is separately classified a Best of Breed may be declared but only from those dogs which have received a first prize in a breed class at the show. Where separate classes are provided for each sex of a breed a Best of each Sex must be declared.  
NOTE: The Best of Breed/Best Any Variety Not Separately Classified/ Best Any Variety Imported Breed Register award relevant to a Category 3 Breed will not be confirmed until the dog has passed an examination by the General and Group Championship Show Veterinary Surgeon.
  - (2) **Best of Group**

Best of Group and subsequent group placings must be selected from:-

    - (a) The Best of Breed winners in each group
    - (b) The dog declared Best from Any Variety Not Separately Classified classes in each group.
    - (c) The dog declared Best from Any Variety Imported Breed Register class or classes in each group.

NOTE: The dog declared Best of Breed/Best Any Variety Not Separately Classified/ Best Any Variety Imported Breed Register from a breed designated by The Royal Kennel Club as a Category 3 Breed is not eligible to compete in the Group competition unless it has passed an examination by the Show's Veterinary Surgeon. If the dog fails to pass the examination it is ineligible to compete in the relevant group.

(3) **Best in Show**

Best in Show must be selected from the Best of Group winners. Reserve Best in Show must be selected from the remaining group winners following the selection of Best in Show.

- 12 Exhibits will not be admitted to Best in Show competition after a period of ten minutes has elapsed since the announcement that exhibits are required for judging, unless they have been unavoidably delayed by previous judging not being completed on time, and then only with the special permission of the Show Management.
- 13 Exhibitors must not pick up dogs by their tails and leads when lifting them nor handle a dog in a manner which causes its feet not to touch the ground when on the move. This is not acceptable. Exhibitors should note that such practice would constitute harsh handling and reports of such practice will be referred to the Committee under Royal Kennel Club Show Regulation F11.
- 14 All exhibitors must be familiar with Royal Kennel Club Regulation F (Annex B): Regulations for the Preparation of Dogs for Exhibition.
- 15 All dogs resident outside the UK must be issued with a Royal Kennel Club Authority to Compete number before entry to the show can be made. All overseas entries without an Authority to Compete number will be returned to the exhibitor/competitor.
- 16 **DOGS IN VEHICLES ON HOT DAYS.** Your dog is vulnerable and at risk during hot weather and The Royal Kennel Club offers the following guidance to help guide you through the do's and don'ts travelling to and whilst at Royal Kennel Club licensed events.
  - When travelling to a show please take a moment to consider whether the route to the show is on a busy holiday route, and leave earlier to avoid increased time in traffic jams.
  - If your vehicle is not air-conditioned seriously consider whether travelling to the show is a good idea at all.
  - The vehicle should be as fully ventilated as possible, and plenty of stops should be taken, with lots of water available to drink.
  - Ensure your dog is not sitting in full sunlight. There should be plenty of free flowing air around the dog.
  - When at the show, never leave your dog in the vehicle.
  - Keep the dog in the shade—take your own shade, for example a large umbrella and always have plenty of water available to drink so your dog stays well hydrated.
  - Avoid your dog taking part in unnecessary exertion, or from standing in exposed sunlight for extended lengths of time.Remember, if you feel hot your dog is very likely to feel much hotter and dehydrated, and this could lead to dire results. Please look after your dog's welfare. **WARNING: IF YOUR DOG IS FOUND TO BE AT RISK, FORCIBLE ENTRY TO YOUR VEHICLE MAY BE NECESSARY WITHOUT LIABILITY FOR ANY DAMAGE CAUSED.**
- 17 Anyone whose dog is entered at a Royal Kennel Club licensed event should take all reasonable steps to ensure the needs of their dog(s) are met, and should not put a dog's health and welfare at risk by any action, default, omission or otherwise. Breach of The Royal Kennel Club Regulations in this respect may be referred to the Board for disciplinary action under Royal Kennel Club Rules and Regulations. The use of pinch collars, electronic shock collars, or prong collars, is not permitted at any show licensed by The Royal Kennel Club. This shall apply at the venue or within the precincts of the show.
- 18 Not for Competition entries will be accepted. Details of each dog so entered must be recorded on the entry form and must be Royal Kennel Club registered. Not for Competition entries will be accepted for dogs aged 3 calendar months of age on the first day of the show.
- 19 No modifications will be made to this schedule except by permission of the Board of The Royal Kennel Club, which will be followed by advertisement in the Canine Press wherever possible.
- 20 An exhibitor or competitor should ensure that contact details for any handler are available and must be provided upon request in any investigation of a breach of this regulation by such handler.
- 21 **Cancellation or Abandonment.** Entry fees will not be refunded in any circumstances where any Act of God or any other unforeseen reason causes the cancellation or abandonment of the show.
- 22 **Best Veteran in Show** is a Veteran which has competed and is unbeaten by any other Veteran exhibited at the same show.
  - Best Veteran in Breed will be selected from all unbeaten veterans from any breed classes provided they are not beaten by any other veteran.
  - Best Veteran in Group will be selected from all Best Veteran in Breed provided they are unbeaten by any other veteran.
  - Best Veteran in Show will be selected from Best Veteran in Group Winners provided they are unbeaten by any other veteran.
- Proviso** For the purpose of this Regulation, dogs beaten in competition for Stud Dog, Brood Bitch, Progeny, Brace and Team or a Special Award confined to one breed will not be considered to be a beaten dog.
- NB: Veterans entered in the Rob Farnsworth Veteran Stakes ONLY are not eligible to compete for Best Veteran in show. To be eligible to compete for Best Veteran in Show, a veteran must be entered and exhibited in a breed class and win Best Veteran in Breed and Best Veteran in Group.
- 23 All postal entries must be made on or before **Friday 17th July 2026** upon the forms enclosed for that purpose. In your own interest please use first class mail.
- 24 Entry fees will not be refunded once an entry is made. The entrance fee of a dog entered but not sent for exhibition will also be forfeited.
- 25 If acknowledgement of entries is required, a stamped, self-addressed postcard with "receipt" written on the reverse side, should be enclosed for the Secretary's signature.
- 26 All dogs must be accompanied and have a strong chain and collar.
- 27 No cages will be provided for Toy dogs. Normal type benching will be provided.
- 28 The Committee is empowered to exclude or remove any dog, which is, in the opinion of the Veterinary Surgeon of the Show, not in a fit state for exhibition owing to disease, vice or other cause.
- 29 The Catalogue will contain the owners' names in each breed in alphabetical order, with their dogs in numerical order. All breeds will be benched together. No bench numbers shall be changed from one pen to another and no dogs shall be benched on any but its own numbered bench. Under no circumstances may partitions between dogs be removed (vide K.C. Reg F(1)4(C)). Exhibits must be removed from their benches half an hour after all judging has been completed.
- 30 Each exhibitor will receive a Free Pass for each dog entered.

- 31 No animal other than a dog duly entered for the Show will be allowed within the precincts of the Show during its continuance. The mating of bitches within the precincts of the Show is forbidden.
- 32 Should any judge be prevented from fulfilling his engagement, the Committee reserve to themselves the right of appointing another in their place. Exhibitors are at liberty to withdraw from competition but no entry fees will be refunded. The Judges will be instructed and empowered to withhold the prize or prizes in any class if, in their opinion, the dog or dogs exhibited do not possess sufficient merit. Judges are not empowered to give prizes beyond those offered in the Schedule of Prizes. All Judges are required to take the Classes in each Breed in the order in which they are entered in the Judging Book.
- 33 Conversation is not allowed in the Judging Ring. Exhibitors showing dogs are not permitted to hold conversation with Judges during the competition and any exhibitors who persist in addressing the Judges after being requested not to do so by the Ring Steward, the Judge, or any of the Committee, may be disqualified and any prize awarded to his or her dog or dogs forfeited. No persons other than the exhibitors (officials excepted) will be allowed in the ring during the judging of classes or specials.
- 34 All Rules & Regulations, or Definitions or Instructions of the nature of Rules and Regulations printed for convenience in other parts of this Schedule shall be deemed to be the Regulations of the Show Committee and shall have the same effect as if they formed part these Regulations.
- 35 The Committee can accept no responsibility for grooming products advertised or sold by Trade Stand holders at the Show and remind exhibitors that grooming products on sale may not meet requirements of the Regulations for the Preparation of Dogs for Exhibition.
- 36 Any owner, competitor, handler or other person in charge of a dog is required to remove as soon as possible any fouling caused by their dog(s) at any Royal Kennel Club licensed show within the licensed venue and within the environs of that event including car and caravan parks and approaches. The Show will provide adequate exercise areas for exhibitors to exercise their dogs in. Exhibitors and handlers are required to clear up any fouling by dogs in their charge. Special bins will be provided for the disposal of fouling. Special Stewards will be appointed to enforce the arrangements.
- 37 Special places will be provided for the convenience of exhibitors desiring to prepare their dogs for exhibition. No exhibitor shall prepare their dog for exhibition anywhere in the Show except these special places.
- 38 Every exhibitor making an entry or entries for the Show shall be deemed to have agreed to abide by The Royal Kennel Club Limited Rules and Show Regulations and it is on this understanding only that entries are received.
- 39 **Dogs in Vehicles.** Remedial action will be taken in the event of dogs left in vehicles being found in a distressed condition.
- 40 The owner, exhibitor, handler or other person in charge of a dog at Royal Kennel Club licensed events must at all times ensure that the dog is kept under proper control whilst at the licensed venue, including its environs, car and caravan parks and approaches.
- 41 A dog may be disqualified by the Board from any award, whether an objection has been lodged or not, if proved amongst other things to have been registered or recorded as having been bred by the scheduled Judge. This shall not apply to a Judge appointed in an emergency.
- 42 Every exhibitor shall ensure that whilst the dog is being exhibited, its handler shall display the correct ring number.
- 43 The Committee of The Royal Kennel Club shall be the final court of appeal or umpire in all questions or disputes of any kind whatsoever (except where such powers are delegated by The Royal Kennel Club), arising out of Royal Kennel Club Limited Rules & Regulations. A person attending or entering a dog for any Show shall, by such act, be deemed to have agreed with the Committee of The Royal Kennel Club or delegated authority to refer any such question or dispute to the Committee or delegated authority, as the case may be, under the provisions of the Arbitration Act 1889, or any statutory notice thereof.
- 44 **Safety of Dogs.** The committee will not be responsible for the loss, detention of or damage to any dog, person or property whether arising from accident or any other cause whatever, or from any act or omission of itself, its officers, agents, servants or others or the damage done by the exhibitors to any person or property.
- 45 **Responsibility.** The committee of the Driffield Championship Dog Show Society will not be in any way responsible for any claim for injury or compensation occasioned by or arising out of the holding of the show or by any reason of the act or default of any person in attendance or present thereat. Neither do they accept any responsibility for loss, damage or theft of any dog tables, cages, boxes or personal effects at this show.
- 46 **Photography & Video Rights.** The Organisers would like to bring to the attention of exhibitors, trade stands, press and visitors that it is a condition of all those attending the event that no filming or other form of recording may be taken or made at the venue without express written permission of the organisers. The taking of photographs in the show venue for sale or reward is strictly prohibited except with the written permission of the Organisers. Press accredited photographers are provided with permission to take photographs ONLY for use in newspapers, magazines and internet sites – this is for news purposes only. There is no objection to the general public taking photographs of general views of the show, provided that these are for private use. Specific dogs may be photographed only with the approval of the exhibitor. No photography or filming is permitted in breed judging rings whilst judging is actually taking place. However, judges may allow it to happen at the end of classes or after the Challenge Certificate is awarded. Filming and flash photography is allowed from outside the rings at all times unless the operation of the camera is actually affecting exhibits. However, if a powerful flash unit is used or it is clear that exhibits are being affected, a ring steward or the judge is empowered to stop the person concerned.
- 47 **Attracting of Exhibits.** The attracting of the attention of exhibits by any method from the ringside is prohibited. It is the duty of the Judge, Stewards or Show Executive noticing such attraction to ask that it cease.
- 48 **Abusive Behaviour.** The society will not tolerate any kind of abusive behaviour to its Officers, Committee or Staff on its showground, Car Park or Caravan Park. Anyone found to be behaving in this manner will be asked to leave and a report sent to The Royal Kennel Club.
- 49 **Gangways.** Gangways must be kept clear at all times; they are a safety feature not to be treated as observation places.

## Definitions of Classes

In the following definitions, a Challenge Certificate includes any Show award that counts towards the title of Champion under the Rules of any governing body recognised by The Royal Kennel Club.

Wins at Championship Shows in breed classes where Challenge Certificates are not on offer shall be counted as wins at Open Shows.

In the case of a dog owned in partnership and entered in Members' classes or competing for Members' Specials each partner must at the time of entry be a member of the Society.

In estimating the number of awards won, all wins up to and including the seventh day before the first closing date shall be counted when entering for any class i.e. **10th July 2026**.

Wins in Variety classes do not count for entry in Breed classes but when entering in Variety classes, wins in both Breed and Variety classes must be counted. First prizes awarded in any classes defined as Special do not count towards eligibility.

If an exhibitor reports before the judging of a class or classes that a dog has been entered which is ineligible, the exhibitor may choose one of the following options:-

(1) **WITHDRAWAL**

The dog may be withdrawn from competition subject to the conditions of Regulation F(1)19.

(2) **TRANSFER**

(a) If a dog is ineligible for a class or classes as regards its breed, colour, sex, weight or height the Show Secretary shall transfer it to the equivalent class or classes for the correct breed, colour, sex, weight or height or, in the event of there being no equivalent class, Minor Puppy and Puppy excepted, to the Open class for the correct breed, colour, sex, weight or height.

(b) For an exhibit entered incorrectly in a Minor Puppy class, Puppy class or Junior Class, which is over age but under twelve calendar months of age, eighteen calendar months of age or 24 calendar months of age respectively, the Show Secretary shall transfer the exhibit to the Puppy class, Junior class or Yearling Class respectively for the correct breed, colour, sex, weight or height and in the event of there being no Puppy, Junior or Yearling Class to the Open class for the correct breed, colour, sex, weight or height.

(c) For any reason other than the above, the Show Secretary shall transfer it to the Open class for the correct breed, colour, sex, weight or height.

(d) If an exhibit arrives late and misses a class, even if it is the only class in which the dog is entered, the dog may not be transferred to any other class.

**Minor Puppy** For dogs of six and not exceeding nine calendar months of age on the first day of the Show.

**Puppy** For dogs of six and not exceeding twelve calendar months of age on the first day of the Show.

**Junior** For dogs of six and not exceeding eighteen calendar months of age on the first day of the Show.

**Yearling** For dogs of twelve and not exceeding twenty-four calendar months of age on the first day of the Show.

**Novice** For dogs which have not won a Challenge Certificate/CACIB/CAC/Green Star or three or more First Prizes at Open and Championship Shows (Minor Puppy, Special Minor Puppy, Puppy and Special Puppy classes excepted, whether restricted or not).

**Graduate** For dogs which have not won a Challenge Certificate/CACIB/CAC/Green Star or four or more First Prizes at Championship Shows in Graduate, Post Graduate, Minor Limit, Mid Limit, Limit and Open classes, whether restricted or not where Challenge Certificates were offered for the breed.

**Post Graduate** For dogs which have not won a Challenge Certificate/CACIB/CAC/Green Star or five or more First Prizes at Championship Shows in Post Graduate, Minor Limit, Mid Limit, Limit and Open classes, whether restricted or not, where Challenge Certificates were offered for the breed.

**Limit** For dogs which have not become Show Champions under Royal Kennel Club Regulations or under the rules of any governing body recognised by The Royal Kennel Club or won 3 or more CC,CACIB/CAC/Green Stars or won seven or more First Prizes in all, at Championship Shows in Limit or Open Classes, confined to the Breed, whether restricted or not, at Shows where Challenge Certificates were offered for the Breed.

**Open** For all dogs of the breeds for which the class is provided and eligible for entry at the Show.

**Any Variety not Separately Classified** For breeds of dog for which no separate breed classes are scheduled. These classes are not open to breeds which are listed on the Imported Breed Register.

**Imported Breed Register** For breeds confined to the Imported Breeds Register and only when an Interim Breed Standard has been published by The Royal Kennel Club. Such breeds may be exhibited in this class, with the Best Imported Register / Best Imported Register Puppy being eligible for Best in Group / Best Puppy in Group or Best in Show / Best Puppy in Show as relevant. Such breeds may be entered into Imported Breed Register classes and/or Any Variety or Stakes classes, with the exception of AVNSC classes, for which they are not eligible.

**Not for Competition** Societies may at their discretion, accept Not for Competition entries. Societies may accept such entries from breeds of dog not included within the title of the Society and at Shows held over more than one day, such entries may be accepted on any day from any breed.

**Special Beginners** For owner, handler or exhibit not having won a Challenge Certificate or Reserve Challenge Certificate, or for those breeds not allocated Championship Status, Best of Sex or Reserve Best of Sex at a Championship Show.

**Veteran** For dogs of not less than seven years of age on the first day of the Show.

**Rob Farnsworth Veteran Stakes Class** For dogs of not less than seven years of age on the first day of the Show. Does not qualify for Best Veteran in Group or Best Veteran in Show.

**Champion Stakes** For dogs which have been confirmed a Champion or Show Champion under Royal Kennel Club Regulation or under the rules of any governing body recognised by The Royal Kennel Club.

**Puppy Stakes** For dogs of six and not exceeding twelve calendar months of age on the first day of the Show.

**Junior Stakes** For dogs of six and not exceeding eighteen calendar months of age on the first day of the Show.

**Yearling Stakes** For dogs of twelve and not exceeding twenty-four calendar months of age on the first day of the Show.

**Young Royal Kennel Club Members' Handling Classes** All of the following YRKC handling specific rules are to be read in conjunction with the full rules available on the YRKC website and by entering this class you confirm that you have fully read and understood those rules:

- YRKC members and their reps agree to abide the YRKC code of conduct.

- YRKC Handling judging will be in accordance with the YRKC Handling Judging Criteria.
- You must be a current YRKC member to enter YRKC handling classes.
- YRKC handling classes may be the first and only entry at this show.
- A show offering YRKC handling classes will be offering 3 different classes: 06-11 years; 12-17 years; 18-24 years.
- YRKC Members should enter the age category they would be on the first day of this show.
- Any breed of dog (including Crossbreeds) may be entered into any of the YRKC handling classes at this show. For entry into YRKC handling classes, dogs must be on either the Royal Kennel Club breed register or the Royal Kennel Club activity register.
- A handler not enter the same dog into multiple handling classes at the same show.
- After entries have closed, competitors may only switch dogs if both (1) The dog has not already entered (or has already competed in) another YRKC handling class at the same show; (2) The dog must already be entered at the show (i.e. the breed class).
- First and second place in each age category will guarantee qualification to Crufts 2027. When placing in a class, please ensure that the steward takes down your name and YRKC membership number to record on the score-sheet.

**Good Citizen Dog Scheme** For dogs that have achieved GCDS Bronze Award certificate or above.

**Royal Kennel Club Breeders' Competition – Please Note: Dogs which take part in the Breeders Competition, but are not entered in the show, are required to complete an appropriate entry form declaration, signed accordingly. Owners of these dogs must attend the Secretary's office to complete the entry form if not already entered before the closing date. (Royal Kennel Club Regulation F1(10)).** Each team will consist of a minimum of three and maximum of four dogs of one breed, all bred by the same breeder or breeding partnership. The breeder enters the class and then arranges which dogs are exhibited on the day of the show. Please clearly state the name and affix of the registered breeder(s). Entries will not be taken on the day of the show. Teams will be awarded points/prize money in the RKC Breeders' Competition as follows: Points 1st; 30; 2nd 15; 3rd 10; 4th 5. Prize Money £25 for each Group winner. These points will be recorded in the Royal Kennel Club Breeders Competition record book through the year. The top 40 teams will qualify including the winning teams from the European and World Dog Shows' breeders competition. Our Dogs will collate the points and publish a leader board through the year.

## REGULATIONS FOR THE PREPARATION OF DOGS FOR EXHIBITION F (B)

- 1 These Regulations must be observed when a dog is prepared for exhibition and/or exhibited at any Royal Kennel Club licensed event. Objections may be referred to the Board for disciplinary action under these Show Regulations and/or for disciplinary action under Royal Kennel Club Rule A11.
  - (a) A dog found to have been exhibited in breach of these Regulations will automatically be disqualified from exhibition at the show and from any award gained thereat.
  - (b) Unless the exhibitor provides a satisfactory explanation for the dog being exhibited in breach of these Regulations then he/she may be subject to further penalties of either a fine or as listed under Rule A11.
- 2 (a) No substance which alters the natural colour, texture or body of the coat may be present in the dog's coat for any purpose at any time during the Show. No substance which alters the natural colour of any external part of the dog may be present on the dog for any purpose at any time during the show.
  - (b) Any other substance (other than water) which may be used in the preparation of a dog for exhibition must not be allowed to remain in the coat or on any other part of the dog at the time of exhibition.
- 3 No act or operation which alters the natural conformation of a dog or any part thereof may be performed except:-
  - (a) Operations certified to the satisfaction of the Board.
  - (b) The removal of dew claws of any breed.
  - (c) Operations to prevent breeding provided that such operations are notified to The Royal Kennel Club before neutered dogs are shown.
- 4 Nor must anything be done calculated to in the opinion of the Board to deceive.
- 4 The Board without previous notice may order an examination of any dog or dogs at any show. Any examination thus ordered will be made by a person having executive authority who shall have a written directive from The Royal Kennel Club in their possession. Samples may be taken for further examination and analysis.
- 5 An individual has the right to lodge an objection to a dog only if he/she is the owner or handler of a dog competing in the same breed or class. An objection may, however, be lodged by an official of the show or by anyone so deputed by The Royal Kennel Club. It will be the responsibility of the individual who lodges the objection or the official (as appropriate), to substantiate the grounds for the objection. The Royal Kennel Club will substantiate the grounds for an objection made on its behalf.
- 6 Any objection by an individual related to an infringement of these Regulations must be made in writing to the show secretary at his/her office before the close of the show and the individual must produce evidence of identity at the time of lodging the complaint.

**The attention of exhibitors is drawn to the fact that any advertisement for a coat preparation or shampoo or similar in either Schedule or Catalogue does not imply that the use of such preparation may not contravene Royal Kennel Club Regulations for the Preparation of Dogs for Exhibition F. This also applies to any coat preparation or shampoo or similar on sale at the Show. The attention of exhibitors is directed to the Declaration they are required to sign on the entry form.**

## **THE ARTMEIS VETERAN OF THE YEAR 2026**

The Best Veteran in Show and Reserve Best Veteran in Show will qualify for the Final to be held at Birmingham National Dog Show in May 2027.

The overall Winner and Reserve, at the Final will receive Cash Prizes.

The final will be judged on a points system with three judges awarding points for type, conformation, and movement.

### **IMPORTANT INFORMATION REGARDING BENCHING & IDENTIFICATION OF DOGS**

It is a Royal Kennel Club requirement that exhibitors display the exhibit / bench number on their crate, cage or container at all times. This is particularly important when cages etc are not on benches, and at unbenched shows.

Each exhibitor is responsible for providing their own crate or cage identification and should note that the original exhibit / bench number card, as provided by the show society, must not be used for this purpose.

It is important to be able to contact exhibitors and identify dogs where a dog may be in distress or where the crate might be blocking a gangway.

At benched shows soft crates may only be put on benches if they are the appropriate size for both the dog and the bench, and the crate can be securely attached to the bench.

Both of these points were introduced with the safety of all in mind, but most importantly that of the dog, and to minimise potential incidents and injuries.

The Royal Kennel Club would also take this opportunity to remind exhibitors that the Show Regulation F(1).16 requires that dogs should be present on their benches at all times except when being judged or prepared for exhibition.

### **ONLY DOGS ENTERED IN THE SHOW ARE ALLOWED WITHIN THE SHOWGROUND (Includes NFC and Spectator Dogs)**

#### **Passes for Removal**

You are reminded that Removal Orders MUST be produced when leaving the showground for ALL dogs in your vehicle.

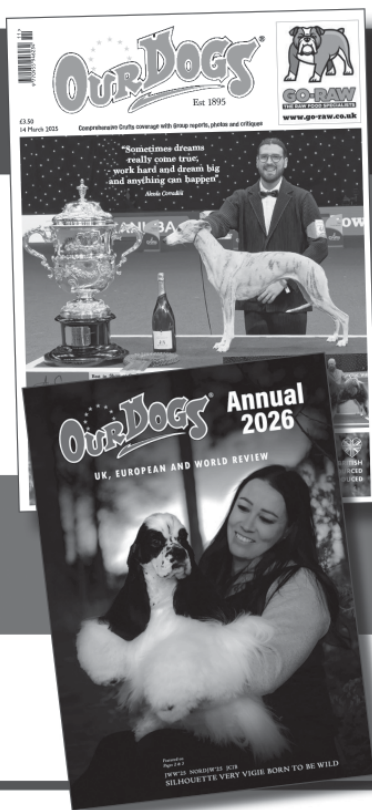
